Serving the Summerville Union High School District, Summerville Elementary School District, and a portion of the Soulsbyville School District south of Highway 108.

Term Expires: 2028

Whitehead succeeds retiring board member Juliana Feriani.

• Melissa Higgins, Trustee Area Four:

Serving the Big Oak Flat-Groveland Unified School District and a portion of the Curtis Creek School District south of Highway 108.

Term Expires: 2026

Higgins was appointed to the board in November, filling in a vacant seat.


Returning Trustees:


Steven Treat, Trustee Area Two
